The program provides food, financial assistance and referrals to residents of 29 zip code areas of Houston. Financial assistance is targeted to help with a family's rent, utilities, prescriptions or other medical needs. Services were provided to 12,131 people in crisis during 2023.

4b (Code:) (Expenses \$ 417,961. including grants of \$) (Revenue \$) JobNet assists the unemployed in conducting an effective job search. In 2023, 487 people were helped.

4c (Code:) (Expenses \$ 362,974. including grants of \$ 293,299.) (Revenue \$) Back to School provides disadvantaged students with grade-appropriate school supplies and new clothing at the start of each school year. A total of 4,071 students received assistance in 2023.
